CONDITIONS OF HORSE PERMIT (LIVERY YARDS) – RUSHMERE & RAMMAMERE HEATH

1. *Permits are for riders from the named yard only and must not be transferred.*
2. *The permit applicant shall be responsible for ensuring that all riders using the permissive routes under that permit are adequately covered by insurance. This needs to cover the horse and rider with **public liability indemnity of at least £5,000,000. A copy of a current Certificate of Insurance must accompany an application for a permit.***
3. *The permit holder shall keep to the designated permissive horse routes and public bridleways within Rushmere, Rammamere Heath and King's Wood as shown by directions in the wood and/or marked on the official Horse Permit Routes map.*
4. *The permit holder shall not interfere with any person's lawful enjoyment of the land, and shall not use the permissive routes in any way so as to endanger any other member of the public using the paths.*
5. *The permit holder shall refrain from constructing any jumps, or making alterations of any kind to the routes without the prior consent of the Greensand Trust.*
6. ***The permit holder shall clearly display a valid permit card at all times whilst using the permissive routes.***

Persistent failure to display a valid permit card may result in the withdrawal of the permit. Should your permit card be lost or mislaid please inform Stockgrove Country Park.

7. *The permit holder shall reimburse the land owner in respect of any damage (other than normal wear and tear of routes as a result of normal use under this permit) caused to the land, or any property on the land, by himself/herself or the horse.*

I agree to abide by the above conditions, the byelaws and other regulations of the site and all current and relevant health and safety guidelines.

I enclose a copy of a current Certificate of Insurance as specified above.
